The detailed agenda of the meeting will be as follow:

1. Revision of the syllabus, course code, course credits and addition of new course in the BPT as per feedback from the stakeholders.
2. Revision of the course code of semester 5th and implementation of PTY307 of General medicine – I lab from PTY309 of General medicine – I lab from batch 2019 onwards.
3. Initially we were using CT-I, CT-II, CT-III, CT-IV clinical training of semester V, VI, VII, VIII from batch 2017/2018 respectively, but to maintain the uniformity of course code of physiotherapy course we want to introduce PTY317, PTY320, PTY417, PTY420 for the clinical training of the respective semesters from batch 2019 onwards.
4. Credits should not be assigning to the clinical training of V, VI, VII, and VIII semesters as there are no criteria to evaluate the clinical training, so only contact hours are considered for fulfillment of the course from batch 2017 onwards.
5. Introduction of Rehabilitation and community medicine subject of semester V from batch 2020 onwards as per feedback from the teachers and need to be taken.
6. There is a change in the code of environmental sciences i.e. EVS001 instead of EVS101 in the previous batches, so EVS001 code of environmental sciences is incorporated from 2020 batch onwards.
7. The subject entitled Practice of Physiotherapy was changed to Ethics of Pedagogy in physiotherapy and is implemented from batch 2017.
8. As per feedback from the students Seminars are also implemented in semester 8th of BPT course scheme and syllabus for enhancement of skills development which is incorporated from batch 2020 and is none credited.
9. As per feedback from the teachers there is an interchange of professional communication skill subject in semester I and II of BPT course instead of semester V as we added practical credits to it and is divided into two semesters.
10. There is a change of subject nomenclature of psychology into general and health psychology which is incorporated from batch 2020 onwards as per feedback from the teachers.
