- IPC-I/Bhartiya Nyaya Samhita (BNS),2023 LAW102 is reshuffled from semester VII to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme.

- Family Law II is reshuffled from semester IV to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme.

3) In BALLB 3rd Semester

- IPC-II/Bhartiya Nyaya Samhita (BNS),2023 LAW 201 is reshuffled from semester VIII to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme.
- Constitutional Law I is placed in this semester with new course code that is LAW 203 instead of LAW 201.

- Civil Procedure Code & Limitation act LAW 308 is reshuffled from semester IXth & Xth to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme.

In addition to this, C.P.C I & C.P.C II is Clubbed from semester IXth & Xth to a single subject namely- Civil Procedure Code & Limitation act LAW 308 , to the instant semester.

- Law of Evidence / Bhartiya Sakshaya Adhiniyam LAW 310 is reshuffled from semester IXth to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme.
- Public International Law LAW 312 is reshuffled from semester IInd to the instant semester with a view of better construction of basic structure of the curriculum.

7) In BALLB 7th Semester

- Administrative Law is placed in this semester with new course code that is LAW 401 instead of LAW 407
- Labour & Industrial Law I LAW 403 is reshuffled from semester Vth to the instant semester with a view of better construction of basic structure of the curriculum.
- Alternative Dispute Resolution (Practical- I) LAW 405 is reshuffled from semester VIIIth to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme. In addition to this, the bifurcation of subject credits is also changed from 5:1:0 to 4:0:2.
- In Alternative Dispute Resolution (Practical- I) LAW 405, the student must undergo through a theory examination of 50 marks. In addition to this, practical file should also be duly prepared carrying a total of 30 marks (10 exercises carrying 03 marks each). Furthermore, student shall be assessed with assessment of 20 marks with reference of classification of maximum marks = 100 in the scheme of this subject.
- Environmental Law LAW 407 is reshuffled from semester Vth to the instant semester with a view of better construction of basic structure of the curriculum. In addition to this, detailed syllabus of the subject is also amended accordingly.
- Information Technology & Cyber Laws LAW 409 is reshuffled from semester VIII th to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme.

8) In BALLB 8th Semester

- Interpretation of Statutes is placed in this semester with new course code that is LAW 402 instead of LAW 408

- Labour & Industrial Law II LAW 404 is reshuffled from semester VIth to the instant semester with a view of better construction of basic structure of the curriculum.
- Professional Ethics & Professional Accounting System (Practical- II) LAW406 is reshuffled from semester IX th to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme. In addition to this, the bifurcation of subject credits is also changed from 5:1:0 to 4:0:2.
- Professional Ethics & Professional Accounting System (PR) LAW471, is clubbed from semester IXth to a single subject namely- Professional Ethics & Professional Accounting System (Practical- II) LAW406, to the instant semester.
- In Professional Ethics & Professional Accounting System (PR) LAW471, the student must undergo through a theory examination of 50 marks. In addition to this, practical file should also be duly prepared carrying a total of 30 marks (10 exercises from the respective area of landmark judgments on Law of Contempt and code of professional ethics, carrying 03 marks each). Furthermore, student shall be assessed with assessment of 20 marks with reference of classification of maximum marks = 100 in the scheme of this subject
- Intellectual Property Rights LAW 408 is reshuffled from semester IXth from bucket list and makes a full-fledged subject to the instant semester, thereby included in the mainstream of subjects with a view of better grasp of knowledge of the subject in early years of the programme. In addition to this; detailed syllabus of the subject is also amended accordingly.
- Private international Law LAW410 is reshuffled from semester VIII th bucket list and makes a full-fledged subject to the instant semester thereby included in the mainstream of subjects with a view of better grasp of knowledge of the subject in early years of the programme. In addition to this; detailed syllabus of the subject is also amended accordingly.

9) In BALLB 9th Semester

- Drafting, Pleading and Conveyancing (Practical- III) LAW412 is reshuffled from semester X th to the instant semester with a view of better grasp of knowledge of the subject in early years of the programme. In addition to this, the bifurcation of subject credits is also changed from 5:1:0 to 4:0:2.
- In addition to this Drafting, Pleading and Conveyancing (PR) LAW466, is clubbed from semester Xth to a single subject namely Drafting, Pleading and Conveyancing (Practical- III) LAW412, to the instant semester.

In Drafting, Pleading and Conveyancing (PR) LAW466, the student must undergo through a theory examination of 50 marks. In addition to this, practical file should also be duly prepared carrying a total of 30 marks (15 exercises carrying 02 marks each). Furthermore, student shall be assessed with assessment of 20 marks with reference of classification of maximum marks = 100 in the scheme of this subject.

- Media Law LAW414 is reshuffled from semester IX th bucket list and makes a full-fledged subject to the instant semester thereby included in the mainstream of subjects with a view of better grasp of knowledge of the subject in early years of the programme. In addition to this; detailed syllabus of the subject is also amended accordingly.
- Human Rights Law & Practice LAW 416 is reshuffled from semester Xth bucket list and makes a full-fledged subject to the instant semester thereby included in the mainstream of subjects with a view of better grasp of knowledge of the subject in early years of the programme. In addition to this; detailed syllabus of the subject is also amended accordingly.
- Competition Law LAW418 is newly introduced subject to the instant semester with a view of better construction of basic structure of the curriculum.
- Health Law as 'discipline specific elective (DSE)' subject to the instant semester with new course code that is LAW420 instead of LAW461
- Gender Justice and Feminist Jurisprudence 'discipline specific elective (DSE)' to the instant semester with new course code that is LAW422 instead of LAW 469.
- Forensic Science and Law LAW424 is newly introduced as 'discipline specific elective (DSE)' subject to the instant semester with a view of better construction of basic structure of the curriculum.

10) In BALLB 10th Semester

- Banking Law LAW421 is reshuffled from semester IXth bucket list and makes a full-fledged subject to the instant semester with a view of better construction of basic structure of the curriculum.
- Insurance Law is placed in this semester with new course code that is LAW 423 instead of LAW 454
- Principles of taxation law LAW425 is reshuffled from semester VIth to the instant semester with a view of better construction of basic structure of the curriculum.

- Moot Court Exercise and Internship (Practical- IV) LAW427 is placed in this semester with new course code that is LAW427 instead of LAW 468. In addition to this, the bifurcation of subject credits is also changed from 5:1:0 to 4:0:2.
- Moot Court Exercise LAW468, is clubbed with Internship LAW470 within (merger) and as a consequence named as Moot Court Exercise and Internship (Practical- IV) LAW 427, to the instant semester along with detailed syllabus of the subject is also amended in its entirety.
- 'Election Law' LAW429 is newly introduced as 'discipline specific elective (DSE)' subject to the instant semester with a view of better construction of basic structure of the curriculum.
- Land Laws as 'discipline specific elective (DSE)' subject is placed in this semester with new course code that is LAW 431 instead of LAW 462 along with detailed syllabus of the subject is also amended accordingly.
- Comparative Constitution as 'discipline specific elective (DSE)' subject is placed in this semester with new course code that is LAW433 instead of LAW 464.
