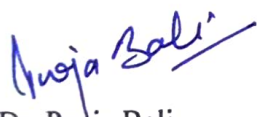

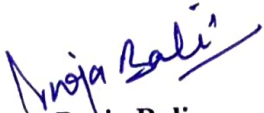

- 1. Addition of Nirmal Sampradaya: History, Literature and Philosophy (VAC050) in B.A. LL.B.**
The proposed inclusion of *Nirmal Sampradaya: History, Literature and Philosophy (VAC050)* with **2 contact hours and 2 credits** in the B.A. LL.B. curriculum from the academic session **2026-27 onwards** is appropriate and academically relevant. The course will provide students with an opportunity to understand the historical, literary and philosophical dimensions of the Nirmal tradition and will contribute towards their broader cultural and intellectual development. The proposal is **recommended for approval**.
- 2. Amendment in the syllabus of Labour Law-I (LAW403)- BALLB 7thsem and Labour Law-II (LAW404) – BALLB 8thsem.** The proposed amendment in the syllabus of **Labour Law-I (LAW403)** and **Labour Law-II (LAW404)**, each carrying **6 contact hours and 6 credits**, from the academic session **2024-25 onwards**, is appropriate in view of the need to keep the curriculum academically relevant and updated. The revised syllabus should ensure adequate coverage of the contemporary legal framework, important judicial developments and emerging issues in labour and employment law. The proposed amendments are **recommended for approval and implementation**.
- 3.** The proposed curricular additions and amendments are academically sound and relevant to the objectives of legal education. The recommendations will enhance the interdisciplinary orientation and contemporary relevance of the B.A. LL.B. and LL.M. programmes.
