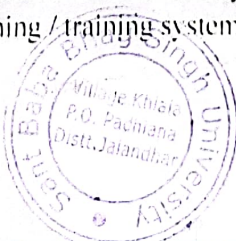
- A) First Party is a Higher Educational Institution named:

CLAUSE 4

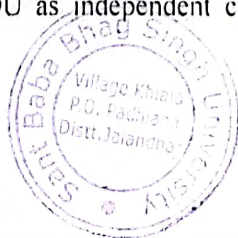
VALIDITY
