THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

## CLAUSE 1 CO- OPERATION

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. Any act on the part of **Techcadd Computer Education Pvt Ltd** the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
